Eligibility for 30 Hours

- For families where both parents are working (or the sole parent is working in a lone-parent family), and each parent earns the equivalent of 16 hours a week at the national minimum or living wage, and earns less than £100,000 a year
- It's a total of 30 hours of free childcare per week, over 38 weeks or the equivalent number of hours across more weeks per year
- If you are offered a place for 30 hours you **must** apply for a code before 31st August 2024 and submit to the school before your child's start date.
